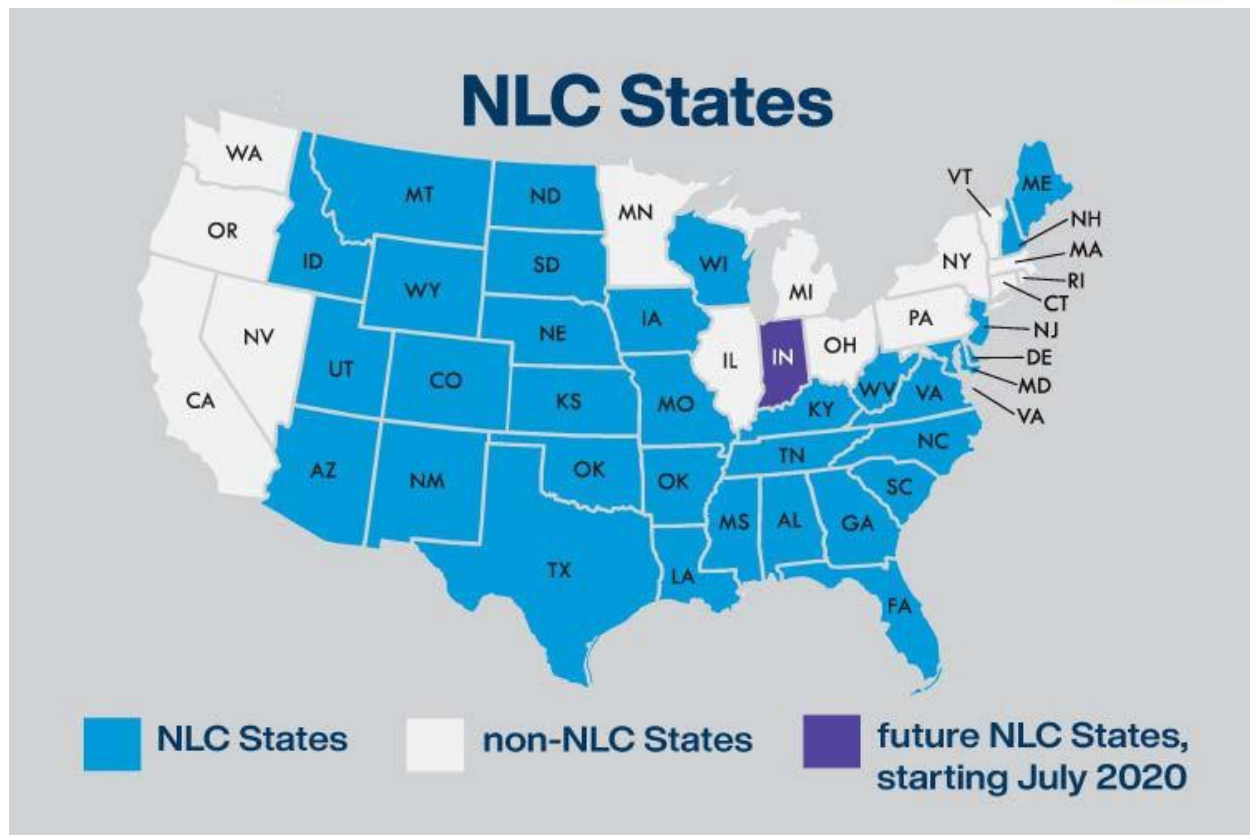
Professional Licensure and Certification Requirements

Each state and territory have different professional licensure and certification requirements. ATA College and Career Education is working to confirm if programs meet the educational prerequisites for professional licensure or certification outside the state(s) of Kentucky, Florida Ohio and Oklahoma. Other licensure requirements may include professional examinations, background checks, years of work experience, fingerprinting requirements, etc. Students who are considering an academic program that may allow them to pursue professional licensure in their state or territory are strongly encouraged to check their state's or territory's information below and contact the appropriate licensing agency to seek information and additional guidance before beginning a program outside of their state. Licensing board and contact information is provided under each state.

Please note that ATA teaches to the license and certification standards of the Commonwealth of Kentucky, Ohio, Oklahoma and Florida. If you plan to work in any state other than those mentioned above, it is your responsibility to verify that state's permit, license or certification requirements before enrolling in a ATA College and Career Education training program. A state's requirement may include, among other things, specialized training that is not required in the states where ATA has a physical presence and as a result may not be sufficiently covered in ATA's curriculum. ATA disclaims responsibility for failure of any student to meet the educational requirements for a permit, license or certification in any jurisdiction other than Kentucky, Florida, Ohio or Oklahoma.

Potential changes in requirements: Students who plan to pursue licensure outside of the states where ATA has a physical presence should be aware that state licensure requirements are subject to changes. While a program may originally meet the educational requirements for licensure, changes in requirements could affect the program's ability to meet any new educational requirements.

An IMPORTANT NOTE for anyone relocating during the course of a program: Prospective and current students should keep in mind that licensing and authorization requirements vary by state and that relocating during the course of a program to another state could impact whether that student can continue in the course, meet the eligibility requirements of that state, and/or receive financial aid funding. If students are considering relocating, they should contact the Student Services Office to check for authorization and licensure eligibility requirements.



Individuals holding a nursing license in any of these states are also considered to have licensure in any other state on the list. Be aware each state may have additional requirements for licensure such as a background check or language requirement.

Florida does not have licensure requirements for the Medical Assistant/Medical Assisting profession. Certification is preferred but not required, however medical assistants must be certified to chart in the medical record.
- There are no states currently that require licensure or certification for the Medical Coding profession. However, some employers require an employee to have certification or registration. ATA Career Education Medical Professional: Medical Coding graduates are eligible to sit for the American Association of Professional Coders (AAPC) Certified Professional Coding Exam (CPC).

- ATA Associate of Occupational Science in Practical Nursing program prepares graduates to apply to sit for the National Council Licensure Examination (NCLEX-PN) to become a Practical Nurse (PN).

Oklahoma State Board of Medical Licensure and Supervision

- The ATA College Associate of Applied Science Degree in Diagnostic Medical Sonography prepares graduates to apply and sit for the American Registry of Radiologic Technologists certification exam. Many employers require professional certification.
- ATA College Medical Assisting with Phlebotomy Diploma graduates are prepared to take the National Health Association (NHA) examination for certification. Oklahoma does not have licensure requirements for the Medical Assistant with phlebotomy profession. Certification may be preferred but not required for employment.

Other U.S. Territories

ATA is currently not authorized to provide distance education courses or to students in American Samoa, Federated States of Micronesia, Guam, Republic of the Marshall Islands, Commonwealth of the Northern Mariana Islands, and the Republic of Palau. Therefore, we have not determined if our programs may lead to licensure in these territories.
